



SCAVENGER HUNT

INSTRUCTIONS FOR GAMEPLAY

The Contest - There are three ways to win prizes in the Bingo Pet Hospice Scavenger Hunt:

- Win the hunt – A city-wide scavenger hunt where teams of 1-2 participants and their dog collect items by solving clues, completing activities around the City of Greensboro and solving the puzzle at the finish line. Late registration will begin at 9:30 am on Saturday, September 17th. The hunt will begin at 10:00 am when clues will be distributed and end at 3:00 pm. The winning team will be the first team over the finish line with all of the required items and solving the final puzzle.
- Be a Best Friend and raise the most money for Bingo Pet Hospice – Participants collect money from family, friends, neighbors and co-workers to sponsor their Scavenger Hunt participation. Checks should be made out to the Bingo Pet Hospice. A sponsor form is provided in the registration packet.
- Show the most team spirit – Teams will decorate their cars, wear team uniforms and costume their dogs to display their team spirit. Team spirit will be judged at the Start of the Scavenger Hunt with prizes to be awarded at the End of the Scavenger Hunt.

The Rules

- The Scavenger Hunt takes place on September 17th rain or shine at All Pets Considered.
- Participants will form a team of 1-2 persons and their dog and may use only **one car**. Team members must arrive together at the finish line.
- Every team must have a licensed driver over the age of 18 and an insured car.
- Any team member under the age of 18 must have parent or legal guardian's consent.
- Be sure to keep your dog on a leash at all times.
- All items must be found by the team. You may not pay or bribe additional individuals to join your team and complete your tasks.
- Spending money to obtain items is not required.
- Participants must obey all North Carolina laws (traffic and other).
- Fundraising for the Best Friend award begins when team registers.
- All fundraising money should be turned in by 10:00am on September 26th.
- The first team over the finish line with all items and solving the puzzle will win Grand Prize.
- All decisions by the judges are final, no exceptions.

- Digital Camera or Camera-ready Cell phone
- Leash for dog
- A car with a full tank of gas

Consent, Release and Waiver of Liability, Assumption of Risk and Indemnity and Parental Consent Agreement. ("Agreement")

All Participants will be required to sign the waiver and release to complete registration.

A. ACKNOWLEDGMENT AND ASSUMPTION OF RISK

By signing below, I, the undersigned, hereby certify to Bingo Pet Hospice Inc., its directors, sponsors, representatives and volunteers, that:

1. I have requested that Bingo Pet Hospice Inc. permit me to participate in a scavenger hunt in the city of Greensboro, North Carolina (collectively, the "EVENT") which will be conducted by Bingo Pet Hospice Inc., its employees, representatives and volunteers.
2. I understand and acknowledge that participation in the EVENT may involve operating or riding in motor vehicles, walking, running and otherwise traveling to different locations in and around the Greensboro area, and entering onto the premises of and/or engaging third parties in connection with securing or achieving "goals," "prizes," or other matters in connection with the EVENT, and I understand and acknowledge that any one or more of these activities can be dangerous.
3. I am fully aware of and understand the nature and extent of the dangers associated with the EVENT, I am in good health and I have no mental or physical limitations which would preclude my safe participation in such activities, and I am voluntarily participating in such activities with full knowledge of such dangers.
4. I voluntarily assume all risk and manner of injury associated with my participation in the EVENT, including, but not limited to, death or injury from any motor vehicle accident or incident, and death or injury resulting from the acts of any other participants in the EVENT.
5. I acknowledge that the risks listed above are not all the possible risks associated with my participation in the EVENT, and that the above list in no way limits the extent of this AGREEMENT.

B. RELEASE AND COVENANT NOT TO SUE

Having read this AGREEMENT, and in consideration of acceptance of me as a participant in the EVENT, by signing below, I agree to release and, on behalf of myself, my heirs, representatives, executors, administrators and assigns, hereby do release, acquit and discharge Bingo Pet Hospice Inc., its directors, representatives, sponsors, and volunteers from any and all past, present and future causes of action, claims, or demands of any nature whatsoever which I, my heirs, representatives, executors, administrators, and assigns may now have, or have in the future, against Bingo Pet Hospice Inc., its officers, directors, employees, agents, representatives or volunteers on account of personal injury, property damage, death, or accident of any kind, arising out of or in any way related to my participation in the EVENT, whether that participation is supervised or unsupervised, including but not limited to, the negligence of Bingo Pet Hospice Inc. or its directors, representatives, sponsors, and volunteers.

I also agree, on behalf of myself, my heirs, representatives, executors, administrators and assigns, not to sue, or support any legal action against, Bingo Pet Hospice Inc., its directors, representatives, sponsors, and volunteers, in connection with any personal injury, property damage, death, accident, loss, claim, liability, cost or expense of any nature whatsoever arising from or occasioned by my participation in the EVENT.

I understand that I will be solely responsible for any loss or damage, including, but not limited to, death or physical injury, that I may sustain while participating in the EVENT, and that by signing this AGREEMENT, I am relieving Bingo Pet Hospice Inc. and its directors, representatives, sponsors, and volunteers, of any and all liability for such loss, damage or death.

C. INDEMNIFICATION

Having read this AGREEMENT, and in consideration of acceptance of me as a participant in the EVENT, by signing below, I agree:

- (1) to indemnify and hold harmless Bingo Pet Hospice Inc. and its directors, representatives, sponsors, and volunteers, from any and all causes of action, claims, demands, losses or costs of any nature whatsoever arising out of or in any way relating to my participation in the EVENT; and (2) to indemnify and hold harmless Bingo Pet Hospice Inc., its directors, representatives, sponsors, and volunteers, from any and all causes of action, claims, demands, losses or costs of any nature whatsoever (including reasonable attorneys' fees), made against Bingo Pet Hospice Inc. or any of its directors, representatives, sponsors, and volunteers, by any third parties, arising out of or in any way resulting from my participation in the EVENT, including, but not limited to, causes of action, claims, demands, losses or costs resulting from my violation of any motor vehicle or traffic safety law or my violation of any trespass or similar law.

2. I agree to abide by the INSTRUCTIONS, all laws, rules or regulations (including trespass, motor vehicle and traffic safety, and other laws, rules and regulations), and all other safety rules as in effect or communicated to me (whether verbally or in writing) from time to time while participating in the EVENT.

3. I acknowledge that Bingo Pet Hospice Inc. may terminate my participation in the EVENT at any time and for any reason or no reason. I acknowledge and agree that any such termination shall not in any way affect the validity of this AGREEMENT.

4. I acknowledge that I will be responsible for my own medical bills in connection with any injury I receive while participating in the event. I hereby represent that I have health insurance that would cover, and to the extent I do not have health insurance, I acknowledge and agree that I have the means to cover or otherwise pay for, any injury received while participating in the EVENT.

5. If for any reason any provision, clause or term of this AGREEMENT shall be held void or unenforceable by a court or any other tribunal, the same shall not affect the remaining provisions, clauses, or terms of this AGREEMENT, all of which shall remain in full force and effect.

6. I understand that the terms of this AGREEMENT are legally binding and I certify that I am signing this agreement of my own free will, after having carefully read it, and after having had the opportunity to confer with the attorney of my choice, and that I agree to the terms hereof.
